- Webmaster offered guidelines for use of the Al-Anon.ab.ca webmail application Report from Area Secretary:

- an Area ZOOM is set up for area business meetings. It is also accessible to groups throughout the area who need access to an electronic platform for meetings. However, there are scheduling issues and groups as well as officers need to verify that time slots are not double booked. Discussion occurred

around the original intent of the ZOOM platform and how to move forward, ensuring that the scheduling concerns are addressed.

Treasurer's report: donations are down over 2021 by almost \$1500.00. Prudent reserve

Report from the Electronic Meeting Group Task Force:

History of electronic meetings was presented. At the April, 2022 WSO General Assembly, electronic meeting registration with WSO will be discussed. At present: if a

apply to Alberta/N.W.T to be designated as part of Area 80. Discussion needs to occur
